Description:

The M-677 is a durable, high performance, clear material that offers excellent thermal stability, abrasion and moisture resistance. This polyester label utilizes a high performance, tackified acrylic designed for use in demanding environments.

Recommended Applications:

This label is recommended as an overlaminate for durable goods, power tools, equipment and machinery, lawn and garden. For maximum bond strength, the surface should be clean and dry. A typical cleaning solvent is heptane or isopropyl alcohol, consult manufacturer of these solvents for handling and storage parameters, For best conditions, application surface should be room temperature or higher. Temperatures below 10° F (-12°C) can cause the adhesion to become so firm that it will not develop contact with the substrate. Higher initial bonds are achieved through increased rub down pressure.
